

# Glenwood Aquatic Center opening delayed by leak underneath decking

The Glenwood Aquatic Center will not open on Memorial Day as originally planned.

After the swimming facility was filled with water last week, Public Works Director Jamey Clark detected some water loss and identified the source of the leak inside a manifold box underneath the decking near the yellow canopy outside the lockerrooms.

"Jayme noticed Tuesday afternoon there was a little bit of water loss and found the leak inside that manifold box," Glenwood City Administrator Amber Farnan said. "We had that repaired last spring. We didn't get a chance to test the repair because when we turned the pumps on after that repair, that's when we had the big tee crack."

The water-loss issues kept the facility closed for the entire 2022 swimming season. Following an inspection last fall, repair work was completed in April. The work included repairing and sealing joints, replacement and installation of filter tees on a water supply line and the replacement of decking near the diving board area.

The majority of the repairs were completed by Ericksen Construction, the original contractor for the aquatic center, with guidance from JEO Consulting, the engineering consulting firm for the construction of the seven-year-old facility. Although the warranty for the aquatic center has expired, JEO agreed to assist the city in making the necessary repairs and covering the costs.

Farnan said city officials believe the repair work conducted underneath the deck in June 22 (where the leak was detected last week) is still under warranty.

"We believe this to be warranty work because since the repair was made less than a year ago and it was not sucessful," she said. "JEO has recommended how they

would like to see that fixed."

wood Aquatic Center in June 2022.

Farnan said Public Works employees would remove concrete from around the manifold box so the contractor can get in to see what needs to be repaired.

The pool still has water in it and two sump pumps are running to keep the water circulating. The hope is that the repair can be made without draining and refilling the pool.

Farnan said the city is committed to opening the facility in 2023.

"We're as frustrated about this as everyone else is,"

# Glenwood hosting state tree climbing competition

# I-29 assault, pursuit suspect arrested in Omaha on Friday

A suspect in a pursuit that took place in Mills County was arrested on Friday in Omaha.

According to a report from the Mills County Sheriff's Office, deputies responded on the evening of May 14 to a domestic violence incident in a vehicle on Interstate 29. Callers told authorities that a female was being assaulted and had tried jumping out of the moving vehicle.

Law enforcement officers attempted

a traffic stop, but the suspect fled, leading law enforcement on a pursuit. The suspect eventually drove through a field. The female victim was pushed out of the vehicle and the suspect was able to flee from officers.

Drones and K-9 units but were unable to locate the suspect.

The suspect – identified as 33-yearold Darontae Orduna of Omaha – was taken into custody Friday in Omaha. Orduna faces multiple charges, including kidnapping and felony domestic assault.

The victim was hospitalized and treated for multiple injuries.

## Scam letter from 'County Deed Records' circulates in Iowa

corder's Office assisted a resident with questions about a confusing letter they received, which was quickly identified as a scam and reported to local law enforcement. The letter claimed to be from "County Deed Records" with false information about the recipient's home warranty expiration date. The letter also contained a "renewal fee voucher" for \$199, which resembles a check and requests immediate action to call or be left vulnerable to repair costs.

The Iowa County Recorders Association, in partnership with Iowa Land Re-

On May 1, the Webster County Re- cords, confirmed that this information in the letter was not legitimate. Similar illegitimate letters have been found across the country.

> Fortunately, in the Webster County incident, the resident came into the Webster County Recorder's office with questions before taking any action.

> The Mills County Recorder's Office issued the following statement in regard to the letter scam.

> "If you or someone you know has received a letter claiming to be from the County Deed Records, please do not respond to the letter in any way. Do not

pay; do not call; do not go to the website and do not return any mail requests.

Webster County Recorder Lindsay Laufersweiler, had this to say about the scam letter, "Scams are everywhere! Thankfully this individual came into the office to research. This mailing was not sent by county recorders. (Please remember to) do your research and ask questions. You'll be glad you did!"

## EMCCS partners with Glen Haven Village on equipment

MALVERN, - East Mills Child Care behind still has use and does not have to a proposed Certified Nursing Assistant Solutions (EMCCS) has partnered with Glen Haven Village nursing facility in Glenwood to repurpose usable nursing home equipment.

In November 2022, EMCCS purchased the former Manor of Malvern nursing facility at 905 North 2nd Avenue. The facility had closed in 2014. Glen Haven staff was able to remove multiple truckloads of equipment.

Meagan Schnoor, President of EMCCS, says, "We are pleased that the nursing home equipment that was left

# My Fitbit insists that I keep walking - all day

I two-step while I cook and pirouette while I unload dishwasher. Then I waltz with the broom—while I sweep up the dishes I broke two stepping and pirouetting.

I just love working in the kitchen!



Not really. And I don't know even how to pirouette. I've just become aware of how much I move since I heard the startling claim that "sitting is the new smoking." I don't believe it any more than I believe orange is the new black and 50 is the new 30. But health experts agree sitting too much does pose health risks, though it is cheaper than buying cigarettes.

I've never been a smoker, but I am a sitter. It just seems so dangerous to use my laptop while I ride my bicycle.

Lucky for me, I have a new fitness tracker, a sporty little doohickey I wear on my wrist and it has truly changed my behavior. If nothing else, I look at my wrist more than I used to.

My Fitbit insists I walk at least 10,000 steps a day which honestly isn't hard for me. Heck, I racked up 2000 steps looking for my cellphone today. I never found it which means another easy 2000 tomorrow.

But just getting 10,000 steps isn't enough for my new fancy Fitbit. Oh no. It tells me to move throughout the day so I can stay fit and get even less work done at my computer than I did before.

If I haven't taken at least 250 steps in an hour, it buzzes me at 10 minutes 'til. I startle easily, so that's always good for a few steps. Then the words "Feed me" float across the screen. So I jump up and march straight to the kitchen. Kidding! It actually says, "Feed me steps," which I think is a poor choice of words for a fitness device.

It wisely says nothing when I don't get 250 steps. If it criticized me, I might fling it against the wall, and that could affect both its accuracy and

And I do fail sometimes. I blame the Fitbit. Unlike my old tracker which I wore on my ankle, this one goes on my wrist and it doesn't seem to count my steps unless I swing my arms while I walk. Other people have told me their trackers credit them with steps for everything from waving goodbye to blow drying their hair. Mine is more persnickety. Whenever I'm carrying anything, I have to do it on my right side so that my left arm can swing. I'm probably going to be lopsided someday.

The last time I was at the grocery store, I steered my cart with my right hand so that I could swing my arm as I walked. It seemed like a good idea until I knocked over a stack of cereal. And I didn't even get step credit for picking it all up.

When I was a teenager, I worked as a server in a restaurant. One of the most valuable lessons I learned was to save steps. I never went to the kitchen without taking some dirty dishes back with me. It would have to be done eventually and my customers weren't likely do it.

No more saving steps these days. Now I make two trips every time I go to the basement so I can get more steps. Also because I forgot why I went down there in the first place.

If I hit 250 by the end of the hour, my Fitbit congratulates me. "Strong stepping," it says. Or "You crushed it." That seems dramatic. I walked 250 steps in an hour. Some people run marathons. Still if sitting is the new smoking, for another hour at least, I can claim to be a nonsmoker.

### **lowa lawmakers listening** to donors, not the public

I attended the legislative coffee on April 15, in Malvern, and while I was there, I expressed my dismay and disappointment that after so many mass shooting have occurred this year, our legislators supported a bill that allows guns on school campuses.

In its original format, the bill would have also restricted private businesses, from being able to enforce a "no guns allowed" policy, but Representative Sieck and Senator Costello and their Republican colleagues listened to the business community, who clearly indicated they wanted to maintain their ability to be free from guns at their businesses.

Incidentally private schools wanted to maintain gun free campuses to protect their staff and students, and the legislature agreed. Public schools, however, will have no such freedom, as the new law specifically states that guns, explosives, and even assault rifles may be brought to schools (elementary through university) and events such as ball games, dances, and other schoolsponsored activities.

Were parents, superintendents, teachers, or school boards asked for their input? What about the students themselves? Our lawmakers are not listening to the public interests. They are listening to their donors.

In a letter to the editor published in the May 17 edition of The Opinion-Tribune, Mr. Joe Pittman mischaracterized me in implying that I was not taking ownership of my own words. While I don't appreciate the implications of Mr Pittman's comments, I'll forgive that it's pretty easy to get us confused when there are so many citizens annoyed and disgusted with so many of the legislators' actions this season.


