Fire marshal concludes investigation into Mulholland's fire; cause 'undetermined'

An investigation by the Iowa State Fire Marshal's Office was unable to determine the cause of a Dec. 13, 2021, fire that destroyed the Mulholland's grocery store building on Main Street in Malvern.

"Unfortunately, we did not come up with a cause. Our official cause is going to be listed as undetermined," Special Agent John Ticer of the Iowa State Fire Marshal's Office said on Monday.

"We were able to rule out a few different things mechanically in the store but there's simply too much damage to fully rule out some other items, including the possibility of some discarded smoking materials," Ticer said. "We were able to examine some of the compressors for some of the cooling units that were for the store. We were able to rule out investigated the fire scene on the a dry goods store.

a few of those, especially some that had most recently been worked on."

Ticer added that based on the information gathered during the investigation, there is no suspicion of arson or foul play.

In addition to discarded smoking materials, Ticer said investigators were unable to rule out the building's electrical system as a possible cause. He also said the amount of destruction caused by the blaze made it more difficult to determine a cause.

"The more damage that occurs, the more difficult it is to find a cause," he said. "Not to say that never happens

- that we can't - because each individual fire scene is unique in and of itself. But, the majority of the time, when we have this much damage, it is very difficult to determine the

Ticer said as far as he's concerned, the book is closed on the investigation. He noted that the fire marshal's office same day as insurance company investigators were at the site.

"We conduct completely separate investigations, however the insurance companies that were involved were there on the same day that we did the scene examination," Ticer said. "The fire marshal's office actually utilized some of the heavy equipment brought in by the insurance companies. We needed to be able to move the large amount of debris that we had.

"I don't speak for them but I would assume their investigation is essentially completed as well with the same undetermined cause."

Ticer said the scene of the fire is now "free" to be cleaned up.

Grocer Tom Mulholland announced in January that he intends to rebuild his store that has been an anchor of the Malvern business community for generations. Mulholland's history in Malvern dates back to the 1870s when it was

Glenwood TeamMates mentoring program growing despite COVID-19 disruption

Despite being disrupted by the COVID-19 pandemic, the Glenwood Community School District's nearly three-year-old TeamMates mentoring program is continuing to grow and serve children across the district.

Glenwood TeamMates coordinator Sandra Dollen said 50 students in grades 3-12 are currently matched with an adult mentor.

"The most important thing is not the number of mentor matches we have, but the quality," Dollen said. "It's very important to me that when I match a student with an adult that they have a good connection and they form a healthy relationship – a long lasting relationship as a friend."

The mentors spend about 30 minutes a week with their mentee

during normal school hours conversing with one another and sometimes taking part in an activity. Dollen said each participating

school in the district has a designated mentoring room or space for mentors and their mentees to meet.

"They can play games. We have a nice ping-pong table, a little golfing turf area, they shoot hoops sometimes, play board games or just chit chat," she said.

Dollen admits the start of the pandemic in 2020 created some challenges as the program was getting

off the ground, but the mentoring continued, even after classrooms were shuttered and the district went into remote learning mode.

"For awhile there we had to go virtual but it was better than nothing at all," Dollen said. "Then, there was a time when the school didn't allow outsiders to come in so the mentors actually set up outside and they did social distancing and connected that way for the majority of the year. That worked out very well."

City council developing solar energy ordinance

Interest in residential solar systems growing in Glenwood

While Mills County officials are having conversations about potential wind and solar energy projects proposed by MidAmerican Energy, the city of Glenwood is moving forward with an ordinance pertaining to solar energy.

The Glenwood City Council passed the first reading of a solar ordinance at its regular meeting last Tuesday, Feb 8.

"We, as a city, have gotten several building permits for solar panels," Glenwood City Administrator Amber Farnan said. "Our current land development ordinance does not address solar panels other than as a conditional use. To do that, we have to have a public hearing and planning and zoning approves those permits.

"By adopting a solar panel ordinance, this will allow us to internally approve those permits without taking it to a public hearing. It will ultimately save the city money because every time we have to do a public hearing it costs us money."

Farnan said all of the conditional use permits for solar panels that have come before the Mills County Planning and Zoning Commission have been approved.

"It also shows us we just need to have an ordinance that we can refer to and just make it an easier process," she said.


Farnan noted the interest in solar energy is on the rise in Glenwood, particularly from homeowners.

"We've had one or two commercial, but most of them have been residential," she said.

The ordinance being considered by the council addresses requirements for height, location, setbacks and easements. Roof-mounted solar systems could not be higher than 10 inches above the roof and groundmounted residential systems could not exceed 15 feet in height "from grade at extended height."

The ordinance also defines a solar energy system and a solar thermal system and addresses size limitations, maintenance and compliance with federal regulations and the state electric code.

Some other items on last week's



council agenda:

■ Following a public hearing, the council passed a resolution for approval of a development agreement with Sell Properties that would authorize Tax Increment Financing (TIF) payments for infrastructure costs associated with development of an apartment complex at the former Glen Haven nursing home building at 302 6th St.

Farnan said the agreement allows project developer Ryan Sell to receive property taxes generated on his investment for infrastructure costs.

"He's asking for up to \$1.04 million in TIF providing he spends that money in infrastructure costs," she said. "He'd probably start getting payments in 2024 or 2025 after it gets on the tax rolls.'

■ The council approved the second reading and waived the third and final reading of a motion that amends the zoning map for the Arbor Hills subdivision being proposed by Jim Hughes Real Estate along the south side of 6th Street. The area is rezoned from Agricultural (Ag) to Urban Family Residential (R-3), which will permit the construction of single family homes, townhomes and duplexes.

The council also scheduled a public hearing for March 8 to designate the Arbor Hills site as an Urban Renewal Area. Farnan set approving the Urban Renewal Area designation is part of the development agreement with Jim Hughes Real Estate and the first step in the TIF process.

"We have to designate it as an Urban Renewal Area before we put a TIF on it," she said. "Once that's done, it will be another month or so before we get an idea of how much TIF he's going to ask for."

Fire marshal issues burn ban in Mills County

Office has issued a burn ban for Mills County.

Mills County Emergency Managements Director Larry Hurst made the request after determining high winds and dry conditions constitute a danger to life and property. The state fire marshal agreed.

The Iowa Department of Pub-

The Iowa State Fire Marshal's lic Safety issued the ban effective Feb. 12.

> The ban prohibits open burning in the county except as specifically permitted by Iowa code or until such time Hurst, representing area fire departments, notifies the state fire marshal that dangers to life and property no longer exist.

Any violating of the ban is a simple misdemeanor.



Mills among counties adopting 'Livestock Master Matrix'

Most of Iowa's 99 counties notimit before they can build in counties fied DNR in January that they plan to evaluate construction permit applications and proposed animal confinement locations by using the master matrix.

With few exceptions, most counties will use the matrix during the next 12 months.

The following counties in Iowa will not use the matrix in 2022: Benton, Davis, Des Moines, Guthrie, Grundy, Keokuk, Lee, Mahaska, Osceola, Plymouth, Wapello, Warren and Washington.

Additional requirements are required for animal confinement pro-

using the matrix. Producers qualify by choosing a site and using practices that reduce impacts on air, water and the community.

When a county adopts the master matrix, the board of supervisors can provide more input to producers on site selection, and proposed structures and facility management.

Participating counties score each master matrix submitted in their county and can recommend DNR approve or deny the construction permit. They can also join in DNR visits to a proposed confinement site.

While all counties may submit ducers who need a construction per- comments to DNR during the permit-

ting process, counties that adopt the master matrix can also appeal a preliminary permit to the state Environmental Protection Commission.

The deadline for enrolling in the program is Jan. 31 of each year.

Find more information, including a map of participating counties, on DNR's AFO webpages under Master Matrix.

The master matrix applies only to producers who must get a construction permit to build, expand or modify a totally roofed facility. Generally, these are confinement (totally roofed) feeding operations with at least 2,500 finishing hogs, 1,000 beef cattle or 715 mature dairy cows.



Gift will help fund Wabash Trace Trail improvements

Trails, Inc. (SWINT) announced on Thursday that their organization has been selected to receive an annual gift of \$25,000 from Dr. Ted and Polly Hoff.

Governor Revnolds has announced a \$100 million investment in Water Infrastructure made available through the federal American Rescue Plan Act of 2021.

A portion of the funding will be dedicated to onsite wastewater systems (septic systems) in unsewered communities. The one-time program will provide grants to property owners meeting certain eligibility requirements and will be jointly administered by the Iowa DNR and Iowa Finance Authority.

The initial priority eligibility will focus on:

1. 460 communities previously identified as having 10 or more homes on 10 acres or less where half of the occupied properties didn't have adequate wastewater systems (septic systems).

2. Properties that were constructed prior to the implementation of statewide onsite system rules.

3. Properties that were not updated during time of transfer requirements.





My fascination with snakes started at a young age

Growing up in nearby Papillion, back then a very small rural community, I saw plenty of snakes around town, most little garter snakes that seemed to live under every woodpile, trash barrel or any other object left lying in the yard.

They were harmless and cute and just the right size for a small boy. As I got older, my interest turned to larger varieties, like bull snakes, black racers and other varieties found in the Midwest. One day I found a nice three-foot-long bull snake in the garden and decided it would be an interesting pet. I was so proud I could catch it and get it into a shoe box, but then I had to run off, so I left the shoe box on the back porch where my mom did her laundry.

Later in the day, I heard a huge commotion and found my mom in battle with the snake and by the time I arrived on the scene, she had killed it with a broom, literally beating it to death. I was lucky I was not similarly dispatched – she was mad at me for days for bringing this reptile into our

On a summer trip to Maine, I found a four-foot black water snake in a brook leading down to the lake and thought I could capture it and show it around to the rest of the family back at the camp. Sadly (for me and the snake), I grabbed it way too far behind the head and it quickly reached about and latched its mouth around my right index finger and was not persuaded to let me go. As blood slowly seeped from the wound, I ran back to camp with the snake still in a death grip on my hand and its long body trying to wrap its way around my arm - a sight to behold, if a bit painful.

Back at camp, my great-grandmother, in her upper 80's at the time, was not a bit perplexed about what to do about this problem. She grabbed a hatchet and told me to follow her to a nearby stump and there she told me to place my right hand on the stump as she pulled the snake taunt with her left hand. With her right hand, despite my fear and protests, she quickly cut the snake in two about a half foot from my hand as I yelled bloody mur-

Well, the snake, now without a body, finally let me go. This daring feat on her part amazed me for years.

My wound quickly healed but for a couple weeks I had the tooth marks well delineated on my right index finger. Lesson – don't pick up a snake too far behind the head!.

Later on, while at my college USAF summer camp in Texas, we learned how to catch poisonous rattlesnakes and then kill and eat them as part of our survival training. Yes, they taste like chicken.

Years later, when I was now in the

USAF and stationed in Arizona, we often saw rattlesnakes while horseback riding in the desert – I stayed FAR away!


In the many years we lived on a large acreage in Ohio, we often saw snakes of all varieties, and thankfully, there were no poisonous types in our area. I was most intrigued by the long black water snakes that lived in the pond. They were pretty shy but I was amazed how quickly they could glide across the pond, sometimes even with a small bluegill in their

Often while out mowing, I would come across larger bull snakes or similar types sunning themselves near the garden or looking for small rodents out in the meadows. I have learned over the years how beneficial the snakes are to controlling rodents and that almost all snakes, even rattlers, will likely warn you first rather than strike without provocation and almost always will go the other way when confronted.

A few years ago, I had the opportunity to go snorkeling in the crystalclear waters of the Sucuriu (Anaconda in Portuguese) River in the Pantanal Region of southwestern Brazil. This area is not surprisingly then, home to massive Green and Yellow Anacondas. Some have been captured in the area over twenty feet long and weighing over 120 pounds, but rumors of much larger snakes abound. This made me more than a little nervous, but being in my black wet suit, I probably appeared more like a small hippo and probably would appear to even a very large snake, even more than they could swallow. Still as I peered into the depths, I had that fateful music from "Jaws" always in my mind - the same feeling I always have whenever I am swimming in ocean water deeper than six feet.

I did not see any anacondas that day and am content that I didn't. If I had, my bodily reaction might have drawn the attention of piranhas which also live in that river.

Bottom line on snakes – they are among the good and most beneficial of creatures, save perhaps for the one that tempted Eve those many years ago in the Garden of Eden.

TeamMates, founded in 1991 by former University of Nebraska football coach Dr. Tom Osborne and his wife Nancy, is a nationallyrecognized "one-to-one, relationship-based" mentoring program. TeamMates programs exist in five states -Nebraska, Iowa, Kansas, South Dakota and Wyoming. The program has been established in 29 school districts across the state of Iowa, from as far west as Glenwood to Waterloo in the east and Storm Lake in the north.

TeamMates CEO DeMoine Adams, said the number of chapters continues to grow, particularly in southwest Iowa. Stanton is the latest Iowa school district to start a TeamMates program.

"Southwest Iowa is really where we're going to blow up," Adams said. "That's where there is heavy interest."

Adams, a former Nebraska and professional football player, spent the day in Glenwood on Friday meeting with mentors and students to promote the positive benefits of the program. Speaking to students during the lunch hour at the Glenwood Middle School, he stressed the importance of having positive adult role models in their lives.

"All of the teachers and the adults here will admit we had role models in our lives to help get to where we're at. Because without having a positive role model, you may make the mistake of limiting your potential or wasting your potential," Adams said. "All of you have potential, but it takes those positive, caring adults to help you see your potential and to reach it. In life, choices give you chances or consequences and you win or lose how you choose."

Adams invited the students to join the team.

'TeamMates is a winning team and when students choose to be a part of TeamMates, it increases their chances of being a winner in the classroom by being a leader instead of a follower," he said.

During an interview following his presentation at the middle school, Adams commended Dollen and the Glenwood mentors for the success of the program. He said the pandemic has been tough on children but mentors

of their anxiety.

"I'm very proud of our mentors for being there for our students in a time when anxiety, depression and mental health have been issues for our students," he said. "A lot of our mentors stood up and stayed committed."

Adams accompanied Glenwood TeamMates mentors and mentees to the Rams' varsity boys basketball game Friday night against Denison. He addressed the crowd at halftime and encouraged adults in the audience to consider giving up 30 minutes of their time each week to make a positive impact on a child's life.

Dollen said Friday night's recognition at the basketball game was an opportunity to showcase TeamMates to the community and allow mentors and mentees to spend time with other program participants. Group activities take place at various times throughout the year, Dollen said.
